There is a public comment period currently open for consideration of exiting all schools and LEAs from school improvement status. Ms. Kudrna asked if we can create a subcommittee to stay informed when things like this arise that may require organization input. Dr. Olguin shares that he does receive emails and notifications and it would behoove him to let the board know to keep them informed.
